The delivery of the requirement would be structured into two phases, which are:

Phase 1 - include the design and layout works for the electrical wiring, ventilation pipe works of the new unit that will be connected to the existing HVAC layout systems within the premises.

Phase 2 - Cost management include service works and maintenance of the new chiller air cooler unit installed.
