Introduction

Hildenborough Parish Council is South East of Sevenoaks Town within the Borough of Tonbridge and Malling just off the A21 in Kent. The Parish Council are looking to improve access to local services for its residents and support local residents in their activities.

The Parish Council has a number of areas of open space including the Village Green, Woodland, Play Areas and Pavillion and is now seeking to enhance the Recreation Field area by providing a pathway around the site allowing for wheelchair access, walkers and joggers.
