(TRP) The Royal Parks anticipates that a seven (7) year contract will be offered on a fully commercial concession basis whereby the appointed caterer shall pay a concession fee on Net Sales supported by a Minimum Annual Guaranteed Sum. It is anticipated that the opportunity will be published in the last quarter (Q4) in line with the requirements of the Concession Contracts Regulations 2016.
