The North Yorkshire Council ('the Authority') is inviting tenders from suitably qualified and experienced Concessionaires who will work in conjunction to design, install, manage, and maintain the EV charging network across the county. The successful Concessionaire will be entitled to income generated throughout the contract due to a revenue share agreement. In addition to the delivery of EV charge points at mandatory and non-mandatory sites, the successful Concessionaire will be expected to take on the running of existing Authority provisions as and when required.

The term of the Contract shall be fifteen (15) years with the option to extend for a further one (1) year.
