Award decision makers were; Executive Director for Adult Care and Community Wellbeing and Executive Councillor for Adult Care and Public Health.

Key Criteria used in the assessment reflects Section 5 of the Health Care Service (Provider Selection Regime) Regulations 2023. Weightings reflected the need for the service to deliver high quality outcomes to all eligible residents, across all sectors of the community, whilst offering value for money on public spend. The key criteria of value for money received the highest weighting, followed by key criteria of reducing health inequalities, facilitating choice, integration with existing integrated lifestyle services and health care services, collaboration and service sustainability.

This is a Provider Selection Regime (PSR) confirmation of contract award notice. This contract has been awarded under the Health Care Services (Provider Selection Regime) Regulations 2023.
