The Authority has taken the decision to award this Tier 2 MSK Service (which was previously for Thurrock CCG) to incumbent provider Thurrock Health Hubs. The provider is considered most technically capable of providing the most economically advantageous solution to the Authority under the current environment whilst the ICB undergoes restructure, review and alignment of contracts. The Authority is applying the NHS Standard Contract Terms and Conditions to support a combination of services, all of which are part funded under a single clinical contract, to ensure appropriate clinical governance and service delivery quality as well as consistency of service to patients.

The Authority will observe a 10-day standstill from the date of publication of this notice.

The Authority is commencing a procurement-process for it's own MSK Services for the whole of the ICB and will publish appropriate Notices accordingly to communicate any such future changes and opportunities to the market, once final.
