Ageing Well Southwark is a preventative, community-based service for older people and carers in Southwark. Currently, Ageing Well Southwark delivers the following services:

- 1. An information and advice service for older people and carers.
- 2. A facilitation service, which is similar to social prescribing. The service connects older people and carers with their wider community and supports their independence and wellbeing via signposting, referrals, and/or one-to-one personalised support.
