Domestic production of hazardous wastes in the EC is controlled by the European Council Directive 91/689/EEC (the Hazardous Waste Directive, or HWD). The Hazardous Waste (England & Wales) Regulations 2005 and as amended or HWR, implement the HWD into domestic legislation for England and Wales.

For the purposes of the Contract, household waste defined above comprises Non-Hazardous Household Waste and Hazardous Household Waste.
