- Engage with employers, targeting those who have difficulty retaining their workforce, to develop a pipeline of clients.
- Provide advice and guidance to those employers on a 121 basis.
- Develop and deliver a series of workshops focused on relevant themes to those employers.

- Successfully evidence the contracted outputs as required by the funding.

Employers of all sizes based within the North of Tyne region will be eligible to be supported through this programme of work.

To effectively meet the needs of this opportunity, the pool of Technical Specialists will be able to address the retention challenges faced by employers, which are expected to encompass the following areas:

- Change Management
