Scope

Description

Currently across Essex and the wider Eastern Region, there are no residential treatment services to which community services can refer. Individuals requiring these interventions are referred to providers across the country presenting issues in relation to complex needs.

We are seeking a provider to deliver an integrated/eclectic model of delivery, with a combination of shorter term lower intensity programmes and longer term more intensive therapeutic interventions. We are looking to develop a unit with approximately 20-30 beds as well as providing medically assisted detox on site.
