They are able to provide consistency of staff to within the service.

Improving access, reducing health inequalities and facilitating choice - As well as providing additional capacity to see patients which means that they can be seen sooner, the supplier offers weekend services which provide increased access options for patients.

Social Value - The supplier offers a local solution to capacity restraints within the services, offering weekend support which allows patients wider access to services.
