II.1.4) Short description

Southwark Council intends to undertake a procurement exercise to implement a catering services framework for nursery, primary and secondary schools within the London Borough of Southwark.

The aims of the framework include:

- Continued improvement of nutritional quality and consistency of school meals

across Southwark

- Tackling disadvantage and reducing inequalities

- Enhancing social value through job creation for local people, payment of London Living Wage (LLW) and supporting the local economy

- Realising the opportunities for meeting the Council's social value, food security, environmental sustainability and climate emergency agenda.

Within Southwark, there are currently 4 nursery schools, 74 primary schools (including 3 special schools) and 25 secondary schools (including 5 special schools):

- The value of the school meals market in Southwark is estimated at around £8.3m (primary) and £5.3m (secondary) annually

- Currently, most school outsourced contracts are for a single school, rather than a group, each with different contract terms

- Most contracts are currently two to three years in duration, not all schools will require a contract at the same time

The maximum framework term will be 4 years, this includes the initial contract term and the option to extend. Estimated potential sales value of the framework is £4m over the 4 years.
