The switchboard supplies essential power to wards, plants and equipment across the west half of the hospital site (Blocks C,D, E,P,N and Jenner). The existing switchboard is in an adjacent room and all existing outgoing supplies will need to be migrated to the new switchboard. The intent is to re-terminate most of the existing submains cabling sequentially from the old to new switchboard, minimising disruption to the site.
