The Contracting authority seeks to inform the market of its intention to commence a procurement process by early 2025, to establish a Framework for a range of characterisation services.

Access to characterisation services is required to support the provision of relevant information about the physical, chemical and radiochemical properties of wastes and other materials.

It is anticipated that the Framework services include but are not limited to; laboratory analysis, fingerprint services and additional characterisation services, such as technical consulting, across up to 4 lots;
