This is a community-based smoking cessation service that aims to provide structured smoking cessation support to reduce smoking-related health inequalities and provide accessible, person-centered interventions with measurable outcomes.

Smoking is a leading cause of preventable death and illness in Peterborough. Local smoking prevalence (12.9%) is slightly higher than the national average. Smoking rates are particularly high in deprived areas, among people with long term mental health conditions, substance misuse issues, those who are homeless and those in routine and manual occupations.
