### Description

Bath and North East Somerset Council is testing the market to better understand what the market could provide in relation to Homeless Off-the-Streets Direct Access Hostel accommodation, that will also include housing management and support. The primary purpose of the accommodation is to provide an alternative to rough sleeping for people at risk of or already doing so.

We are currently testing the market for:

Option 1: Organisations with:

a. Premises, that they currently own, and which are suitable for use for the hostel provision within

the B&NES area; or
