Additional operational support and infrastructure adjustments are required to ensure service continuity and mitigate unforeseen implementation challenges encountered during the Low Emission Zone expansion programme.

### **VII.2.2) Reasons for modification**

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

The modification addresses exceptional implementation complexities that emerged post-rollout, including infrastructure strain and site-access impediments. These necessitate targeted remedial and support measures to sustain compliance and enforcement capabilities across the affected network.
