The key criteria for the award were weighted:- , Quality and Innovation 40%, Value 5%, Integration/Collaboration/Service Sustainability 20%, Improving Access/Reducing Health Inequalities/Choice 25% and Social Value 10%.

The provider selected achieved the highest overall score against the weighted key criteria. Quality and innovation received the highest weighting as these aspects are fundamental to transforming Public Health Service for Liverpool and achieving the contract objectives. The remaining key criteria were considered to be of equal importance.
