### **Description**

This request for proposal aims to select a service provider to acquire access licences for an online platform that supports self-directed English language learning for adult learners in the city of Bogotá. The selected platform must provide 24/7 access, enabling users to engage with the content at any time and from any location, thereby promoting flexibility and inclusion. The learning experiences should be highly interactive, dynamic, and engaging, with content that adapts to individual learning needs and pace through personalisation features. Licences must be valid for a minimum period of six months. It is considered an added value if the platform includes accessibility tools for people with disabilities, ensuring equitable access for all users. Preferably, the service provider and their platform will guarantee interoperability with our project partner's already existing digital platform through the use of Single Sign-On (SSO). The platform must offer general English content and include access to progress-tracking features that allow both learners and administrators to monitor advancement through detailed reports on usage and engagement.
