VIA Harrow offers comprehensive adult services (18+) for substance misuse, providing support and treatment for individuals struggling with drug and alcohol addiction. They aim to help individuals achieve recovery and maintain a healthy, substance-free life. VIA offers a structured range of services from Tier 1 to Tier 4 to enable this. Tier 1 services include training and advocacy across the community, focusing on education and prevention. Tier 2 services provide targeted interventions for individuals at risk, offering brief educational sessions and signposting to further support. Tier 3 services involve specialist interventions for those with more significant substance misuse issues, including one-on-one counselling and group therapy. Finally, Tier 4 services are for individuals requiring intensive support, involving close collaboration with adult providers to facilitate referrals for specialist treatment and rehabilitation programs. VIA work closely with the CYP provider, COMPASS, to ensure there is joined up working for service users in the transitionary age range (18-24) or when families are impacted.
