- Children's homes

- Associated therapeutic education

This strategic partnership approach-rather than traditional block contracting-will enable greater flexibility and responsiveness to evolving needs. It aims to offer children and young people more adaptable, blended care options tailored to their individual circumstances.

By fully integrating this provision with existing council children's services, DCC seeks to better support children and young people with the most complex needs. The goal is to provide stable homes within Devon, alongside consistent access to education from childhood through to adulthood, helping them thrive and reach their full potential.

DCC is seeking to establish a long-term (10-year) strategic partnership with a provider who shares its values and commitment to supporting vulnerable children and young people. This new wraparound service will focus on those at risk of, or currently in, high-cost and often distant placements-whether due to mental health or social care needs. It will also address the increasing number of children under 13 living in children's homes rather than family settings.

To facilitate the procurement process DCC will adopt a Competitive Flexible Procedure (CFP) in order to introduce an element of Negotiation to this process.
