The winning Provider/s were scored against the key criteria and were ranked the highest scoring tenderers out of the bids received for each Lot. The award decision makers are: Deputy Head of Service IHCCT for Adult Care Services and Head of Integrated Health & Care Commissioning for Adult Care Services. No declared or potential conflicts of interest were identified during the process.
