Services are to be provided on trusts own premises, using trusts own equipment and facilities, typically utilising spare, out of hours, or spare capacity. This can be used in addition to the trusts existing provisions, with the intention to bolster service outputs and improve efficiency. These insourced services are typically provided by medical or clinical providers who can provide the specialist capabilities required to deliver an end-to-end service, including clinical governance and oversight. This Framework Agreement for 'healthcare Services' falls under The Health Care Services (Provider Selection Regime) Regulations 2023 "PSR2023".
