Contract variation is for an increase in capacity and quality of treatment in accordance with the Supplemental Substance Misuse Treatment & Recovery Grant, additional substance misuse treatment costs for rough sleepers and those at risk of rough sleeping and additional prescribing cost and an increase in prescribing costs as approved by OHIP

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

To utilise the SSMTRG allocation and the RSDATG allocation as per the grant conditions from the Office for Health Improvement and Disparities (OHID) and due to the complex integrated nature of the current service, commissioning a different provider would result duplication of costs and disruption to service users.
