The Services consists of two programmes: Programme A School-based approach and Programme B: - Targets Tier 2 Weight Management Service. The Council sought only ONE provider to undertake both programmes. There was no intention to award separate programmes to different providers.

The Contract will commence on 3rd February 2025 with a term of 2 years ending on 2nd February 2027.
