The basis for awarding this Contract and evaluation model was set out in the Instructions to Tenderers and is the most economically advantageous tender. The Award Criteria included Basic Selection and Key Criteria combining Price (weighted at 30%) and Quality (weighted at 70%), covering:

1. Quality and Innovation
2. Value
3. Integration, collaboration and service sustainability
4. Improving Access, reducing health inequalities, and facilitating choice
5. Social Value

The Authority's evaluation produced a total score for each tenderer; the highest score representing the most economically advantageous tender was awarded the contract.
