Provision of A frame Swings to include cradle and flat seats and a basket swing. The design must maintain the current accessibility of the site.. Quotes provided must be itemised and include the option for fencing and gates, also itemised separately on quotes.

Quotes must include options for the provision of relevant surfacing in line with Health & Safety requirements

Quotes must include for the removal and disposal of old equipment

The contractor will be responsible for providing relevant site set up, safety fencing and ensuring welfare requirements are in place for operatives for the duration of the works.
