Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

A change in contractor cannot be made as the Supplier is uniquely placed to advise HMG and the project is at a critical stage close to completion. This means a change cannot be made for economic and technical reasons. Further, any change at this stage would cause significant inconvenience and substantial duplication of costs and could also result in the project not being delivered to time.
