This is a Provider Selection Regime (PSR) confirmation of contract award notice. This contract has been awarded under the Health Care Services (Provider Selection Regime) Regulations 2023. For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award. This contract has now been formally awarded using direct award process C.

The approximate annual value of the contract is £635,965.

The contract term is from 1st April 2024 to 31st March 2025, with the option of a 1-year extension to 31st March 2026.

The therapy service is for young people living and working in the City of London or Hackney.

The current provider of the Service is meeting the contractual requirements to a satisfactory level and the intention is to award the providers the contract for the period 1st April 2024 to 31st March 2025 (with the option of an additional year extension), Following PSR Direct Award Process C as there is no change to the contract terms.

The annual value of the contract is £635,965. The total value of the contract, including extension, would be £1,271,930.
