The Authority intends to award a contract via SBS Framework SBS10203 - Insourcing of Clinical Support Services, following a Direct Award - Process C, in accordance with The Health Care Services (Provider Selection Regime) Regulations 2023 ("PSR 2023"), to Medinet Clinical Services Limited, based on service delivery to date, value for money and capability within this area of healthcare provision.

The provider will deliver a consultant led Rheumatology Outpatient service six (6) days per month in West Sussex.

- Contact the on call team if a patient needs admission on the day
- Prompt Notification of any incidents
