The successful provider(s) were selected based on offering the most advantageous

tender by scoring the highest combined score against the key criteria question and pass the financial element i.e. Confirm that they would deliver the service for £500 per session as evaluated against the published evaluation criteria as detailed within the ITT.

As a result, they are the recommended provider(s) and will be been awarded the contract, subject to final agreement.
