NHS Frimley ICB ("the Commissioner") sought to commission provision to provide emotional wellbeing and mental health support service to children/young people aged 10 to 17 years of age in North-East Hampshire and Farnham.

Young Person's Safe Haven will provide a safe, calm environment offering a holistic emotional wellbeing and mental health support service to children/young people aged 10 to 17 years of age.

Frimley ICB has followed PSR Direct Award C for the contract to which this notice relates.

The total expected value of the contract for the initial 6-month contract term is £38,116.50. The optional 6-month extension expected value of the contract is £38,116.50. Therefore, the full expected lifetime contract value (6-month + optional 6-month extension) is £76,233.00

The contract period will commence on the 01 August 2025.
