NHS South West London Integrated Care Board (SWL ICB) are inviting suitably experienced and capable providers to submit a response to this market engagement questionnaire and expressions of interest for this potential contract. The opportunity is for the provision of an Open Access Counselling, Community Engagement & Outreach, Advice, Rights and Advocacy Service in the Boroughs of Croydon and Sutton, which is in line with NHS Long Term Plan priorities for expanding Children and Young People's Mental Health Services (CYPMHS) over the next 10 years.
