### **Scope**

### **Description**

The Authority has been managing Traffic Regulated Orders (TROs) in a paper format with a digital system being employed to manage Cambridge City's TROs since the early 2000s. The Authority will move exclusively to a fully digital system of managing TROs because of this procurement.

Currently the Authority produces circa 100 permanent TROs a year with another approximately 2139 (TTROs) being made annually. Permanent TROs will be almost exclusively map based (digital).

The contract is for the supply and support of an IT system that will manage the Authority's

permanent and experimental TRO, allowing the Authority to draft, consult, make, display for the public and record TROs.

It may also have the capability to manage the County's network of Quiet Lanes pursuant to requirements laid out in the "The Quiet Lanes and Home Zones (England) Regulations 2006", and the "Transport Act 2000" s268.

## **Award criteria**

There are a number of Pass/Fail and information only questions, and the Authority is using the Price per quality unit evaluation.

There is no Award criteria weighting split between quality and price for the evaluation:

All Quality questions will have its own individual weighting, and the total will add up to 100%.

This total Quality score will be used to divide the respective bidders' price, as described in section Applying the Price per Quality Point Evaluation Method.

The Final Result will be illustrated in pound sterling (£), and each bidder's result ranked accordingly from lowest cost per unit of quality to the highest in pound sterling (£).

The lowest cost per unit of quality will be considered the most advantageous tender and will be the preferred bidder for this opportunity.
