Scope

Description

To supply 20915 saplings of specified native hardwood species suitable for planting in Tilio-acerion ravine woodlands, via batched deliveries to three project sites. Supply and delivery to take place between September 2025 - May 2026. Quantities, species, delivery sites and intervals are all included in the supporting documentation.

- £59,999 including VAT

If, in this instance, we cannot agree on a suitable alternative species then the contract would be reduced by the value of the unavailable trees.
