Camden Council is reviewing its Experts by Experience contract for people with learning disabilities, which is due to expire in October 2026, with a view to deciding whether and how to re-commission this service.

This service is separate from the range of advocacy, welfare advice, and support services in Camden.

The Council wishes to undertake market engagement in relation to the possible re-commissioning of this service, and therefore would welcome the views of providers on the questions set out in the questionnaire.

Interested parties will not be prejudiced by any response or failure to respond to this soft market testing and a response to this notice does not guarantee any invitation to participate in any future public procurement process that the Council may conduct.
