### **Description**

HMRC is seeking to engage a Supplier to act as a third-party in the procuring of annual online subscriptions on behalf of HMRC.

The supplier will need to have the capacity to engage directly with the providers of the online subscriptions to secure renewal quotes and the best price, and to ensure the renewal process is completed without any gap in service.

Whilst LB (Large Business) are the highest value user of this contract, other business areas also utilise this contract to acquire annual subscriptions such as Financial Times etc.
