Innovation will be a key component of the new service, and the Provider will be expected to use creative, flexible, and innovative approaches throughout the lifecycle of the contract to meet the changing needs of the local population. Key areas of focus will be using innovation to:

- a) Increase access closer to where people live
- b) Increase targeted outreach
- c) Integrate multi-disciplinary approaches across the local system d) Service reach across diverse populations
- e) Meet the needs of underserved groups and those with multiple disadvantage
- f) Embed prevention
