Engagement process description

The Secretary of State for the Home Department, through the ESMCP, is launching preliminary market engagement regarding a forthcoming opportunity to obtain places on a procurement framework for the provision of mobile communication devices for the Emergency Services Network (ESN).

ESMCP has been assessing the devices market for several years and, following recent developments on the ESN programme, is now in a position to invite all interested suppliers to participate in this preliminary market engagement.
