### **Engagement process description**

Suppliers are being engaged with to determine:

- Feedback on our proposed procurement strategy such as if the current Lot structure is relevant.
- If there have been any changes or developments in the market which should be incorporated into the framework scope/specification such as new product lines or a change in insurance provisions.
- Capacity to meet the framework requirements.
- To gain an understanding of whether localised Social Value can and will be offered under the scope of the contract.
- To ensure the market is prepared for carbon reduction plans to be included as a

condition of participation for the procurement.

- Potential risks within the market such as supply chain issues.
- Identification of any barriers to participation faced by SMEs that can be removed or reduced.

Engagement is being undertaken via a Request for Information (RFI) Questionnaire, that is available as a Public Message on the EastMidsTenders eProcurement Portal ([www.eastmidstenders.org](http://www.eastmidstenders.org)). A supplier's participation, or lack of participation, shall not impact the ability of the supplier to participate in any resulting tender exercise. Suppliers should note that any interest indicated does not constitute a commitment to participate in any future tendering exercise.
