The Future Framework will replace the existing NEPO507 Travel Management Services Framework which expires 31.07.26.

This preliminary market engagement notice provides advance notice to the marketplace of the tendering opportunity and NEPO's intention to undertake market consultation activities with suppliers to help shape the future Framework.
