Hull City Council (The Authority) is seeking tenders from interested organisations to provide SEND Outreach Services - Social Emotional and Mental Health Needs (Secondary). The contract is anticipated to commence 2nd January 2026 ending by 1st January 2028 with an option to extend for a period of 3 x 12 month periods.
