Nature and extent of the modifications (with indication of possible earlier changes to the contract):

Additional funding from NHS SEL ICB to be added to the Contract Value which brings the revised annual total Contract Value from £637,099,000 to £647,259,000. The lifetime value is now £3,236,295,000 (£647,259,000 per annum) for NHS SEL ICB.

Additional funding of £3,613,229 has also been added to the Contract Value for 2024/25 only from NHS NEL ICB.

Additional funding of £61,182,720 has also been added to the Contract Value for 2024/25 only from NHSE Specialised Commissioning.

This modification is effective from 22nd January 2025.
