Mileage for travel within Shropshire to meet with children, young people and their families will be invoiced separately at £0.40 per mile for travel within Shropshire only.

The initial term will be for 3 years (36 months) with an option to extend for a further 12

months following review. Therefore the total contract value will be £231,272

The service will provide assessment and direct support for children and young people between the ages of 5 up to their 18th birthday and their families who have experienced or who present with harmful sexual behaviour who live in Shropshire (excluding The Borough of Telford & Wrekin) or for whom Shropshire Council are their Corporate Parent.

All referrals will be from Shropshire Council children's social care and/or safeguarding staff.
