Land is very limited in the area, however a site became available towards the end of the search work around Jan 25, available only as a land sale and development option, ie. the developer will only sell National Highways this land if they carry out the development. This was the only site that meets the full requirements for the A19 maintenance, alternative solutions would not meet the requirements and pose reputational risk to both NH and DfT.
