The Mayor's Office for Policing and Crime (MOPAC) as the contracting authority (known as The Authority) is re-procuring a national framework for the supply of legal services to a range of public bodies including the GLA functional bodies, Police Forces, Police and Crime Commissioners, and other public bodies ("Participating Bodies").

The scope of the National Legal Services Framework Agreement will be to provide legal advice and assistance to Participating Bodies and the contract term will be 48 months in Lots as identified below with an estimated lifetime expenditure across the entirety of the Framework Agreement of up to £35,000,000:
