The service provider will provide non-clinical, personalised support to individuals with a pre-diagnosis of dementia, those with a confirmed diagnosis and their carer's. This support encompasses information, advice, peer support and promoting health and wellbeing. The service aims to provide early intervention, enabling individuals with dementia and their carers to manage health conditions and symptoms effectively, thereby reducing the risk of complications and enhancing their independence.
