The provider will need to work collaboratively with the Trust's women's secure care team, enabling robust discharge from inpatient care to the community, supporting patients to undertake independent living and engage with activities designed to improve rehabilitation and community integration. The provider will work as part of an integrated MDT team lead by the Trust's service manager, contributing to development and progress of patient care plans and recording of such on the Trust's clinical system (RiO).
