We will require 3 twelve week courses to be provided per year per location (15 in total), each such period inclusive of the required residential element of the course which the supplier will be expected to provide in the price agreed. Each course (other than for the residential element) will be run at one of the locations mentioned as specified by us and each course will have a minimum of 12 learners and a maximum of 15 learners.
