The British Geological Survey (BGS), acting on behalf of the European Consortium for Ocean Research Drilling (ECORD), requires a marine coring capability and suitable vessel to operate offshore southern North Sea, Netherlands or Denmark, for a scientific drilling and coring campaign for a period of 30 days (estimated) between June and September 2026 This scientific coring project seeks to extend our understanding of Earth's dynamics during the last 50 ice ages and the warmer periods between them. The North Sea Basin is an area that was heavily impacted by these ice age cycles as climate fluctuated between fully glacial to warmer-than-present conditions.
